WHO IS COVERED BY THIS WARRANTY?

This warranty applies to Quality Surfaces Stone installed in the original purchaser's residence. This warranty is non transferable.

WHAT IS THE PERIOD OF **COVERAGE**?

This warranty remains in force as long as original purchaser owns the home and resides therein for a period of 10yrs from the day of installation

WHAT DOES THE WARRANTY COVER?

Quality Stone installed for residential countertop use.

- Manufacturers defects in fabrication of the stone countertop as determined by the Marble Institute of America, Dimension Stone Manual. VII.
- **Defects** caused by improper installation of your Quality Surface Stone countertops, as determined by the Marble Institute of America, **Residential Stone Countertop** Installation (Technical Module)

Stains from food or beverages. Seam performance.

- Cost limited to repair or replacement of affected countertop piece and not adjoining pieces.
- Does not include plumbing, gas, electrical, tile, wallpaper, painted surface, or trim cost, incurred due to replacement of your countertop. No other warranties are expressed or implied.

WHAT DOES THIS WARRANTY **NOT COVER?**

Countertops moved from their original installation location.

Natural characteristics of stone as

determined by the Marble Institution of America. Including but not limited to; surface pitting, inclusions, fissures, color variations, gloss level, texture, depth, and clarity.

Damage due to physical abuse, including but not limited to; excess weight, standing, sitting, getting on, impacts, excess heat, fire or flame.

Staining due to chemicals, such as but not limited to, stain, paint, oil, acids, cleaners, solvents, alkalies

Damage or injury in part or in whole by acts of God such as but not limited to. settling, job site conditions, structural issues, accidents, or vandalism.

Seam placement, or location, size, color, or appearance of seams, color match piece to piece, or seam separation or failure due to impacts, excess weight, or settling.

This warranty only covers the actual section of countertop where the defect resides. No other costs, expenses, materials, labor, damages, or reimbursements associated with the damaged section are covered under this warranty.

Commercial uses or abnormal conditions, such as but not limited to, use in stores, restaurants, dormitories, offices, exteriors, trains, recreational vehicles, boats or aircraft

WHAT WILL WE DO TO CORRECT THE PROBLEMS?

Inspect countertops. If problem is determined to be caused by an event not covered by this warranty, a service visit may be charged.

Stains from food and beverages will be treated by applying a poultice. This may take more than one application. New sealer will be supplied after the stain removal treatment.

We will repair or replace, at our option, the stone found to be defective.

HOW DO YOU GET AND KEEP THIS WARRANTY?

Show proof of full payment. Fill out and return the warranty card. Use only QS approved products and procedures to care for the stone. Have your countertop sealed by the fabricator every 10 years. How do you get service? Just contact us at


